Public Comment and Questions

Chad Poitras- Mark, can you describe what the Town's fuel assistance program is. What type of fuel

Selectman Blier- Its just K-1 and Propane, no wood or pellets. The program is for Elderly residents or disabled residents who qualify. They can get up to \$200 dollars' worth of fuel.

Dave Harmon- I asked last week about Question 3 on the Ballot.

Selectman Blier- The question was asked about taxes that CMP pays, and whether that would be passed on to the people if question 3 passes. I inquired with the staff up at the capital and was unable to get the answer. They are not sure.

Dave Harmon- The reason why I was asking was that channel 2 news did a segment on it, and they had 2 camps, one said we would have to assume that tax liability, and one camp said we wouldn't. So that's why I was asking.

I also see that there was a posting for the police chief in Buxton a few days ago? Was wondering about that.

Selectman Blier- We don't know why that was posted, we didn't post it. We are very happy with the job that Chief Collins is doing right now, and he has our full support.

Lisa Crockett- Is the application for the Keep the Heat On Program online or at Town Hall.

Hunter Cox- It is at Town Hall. Residents must come in an apply. However, we do require that they apply for the LIHEAP program from York County first. Because we have limited funds, our program is a supplement to the states' program.

Selectman Poitras- We just want people to be aware of the program.

Selectman Blier- Just want to bring up something that happened this week. Recently we had a Code complaint on a leaking septic on a property in Town. The property was not owned by the Town, but if the residents are unable to pay for the repairs, then the Town must pay for them under state law. In this case the residents could not pay and the house was in foreclosure. We paid for the replacement of the septic system, and we will be putting a lien on the property to recover the costs.
