Public Comments and Questions

Patrick Hanna said that two weeks ago, Selectman Blier stated that people on private roads should have curbside trash pickup because they pay taxes. He feels Selectman Blier has a vested interest since he lives on a private road. He also asked, Why aren't other ordinances being enforced?

Selectman Blier commented on the private road question from Mr. Hanna. Curtis Farms Road is a perfect example, the residents are paying taxes to cover the same services as residents on town or state roads. He feels their trash should be picked up curbside, rather than piled at the end of the road. If the trash truck can go down the private road and the road has a turnaround, he feels the residents should have the convivence of curbside trash pickup as well other residents.

In regard to enforcing the ordinance, Selectman Blier explained that the town would have to enforce the ordinance by bringing the resident with the violation to court. The costs would be hundreds of thousands of dollars a year for court cases. The ordinance has a lot of gray areas and that's not the purpose of the ordinance, it's a guideline.

Mr. Hanna gave an example of how COVID-19 affects everyone differently.

Selectman Blier spoke about the new curbside trash ordinance, saying that no one is speaking favorable of the new trash bag portion of the ordinance. He asked if there are any residence who are in favor of the new ordinance to contact the Board.
