E.O. 2223003009 - An order to approve changes to section X, subsection C of the Town of Buxton Personnel Policy as follows.

X.C: Holiday pay for union employees shall be governed by their respective, current collective bargaining agreements.

Full-Time, Non-Union Employees who are required to work on a Town holiday shall receive their regular pay plus applicable holiday pay.

Public Works Employees who are required to work on a Town holiday shall receive an additional time and one-half hours for any overtime actually worked on the holiday.

# Per Diems for Fire/Rescue will be paid time and one-half for hours worked on Thanksgiving, Christmas, and New Year's Day.
