Selectman Blier announced the Town of Buxton is advertising a Tax Sale property at 134 Cemetery Road. The property is out for bid. It is a 'Buyer Beware' property starting at \$20,000.00. The town will hold NO responsibility once it is sold.

Selectman Santolucito checked in with Public Works Director, Kevin Kimball and Officer Camire regarding the technology in the Police Department. He is waiting for the town meeting before they can implement the new program. He also made contact with Greg Heffernan over the weekend. Things are going well and right on target for the town meeting.

Selectman Harmon said we are still getting quotes for the collapsed sand and salt shed. The insurance companies need the sand removed from the sides of the concrete wall to allow the Engineer to complete a foundation inspection. Public Works Director Kevin Kimball is currently getting quotes to remove, store and cover the sand during the rebuilding period and then deliver and stack in the new salt shed once complete.

Selectman Harmon added the Auditors have finished up the pre-audit for year end and she invited other members of the Board to meet with Chief Schools and union negotiators on Wednesday, starting at 9:00AM. She met with the new Facilities Manager today, he starts Monday. She suggested he start by taking an inventory of items needed as well as equipment and supplies. Things are going well in the front office.

Selectman Emery said everything is going well, or his phone would have been ringing off the hook. The town report is at the printer and Meet the Candidate's Night is scheduled for next Tuesday night, May 14th at 6:30PM. Come out to meet and ask questions to the candidates running for Selectman.
