*Review of Projects and Issues*

*Selectman Poitras was notified that this year will be that last year for the people who mow the Ancient Cemeteries, it's been tough to find someone to want to take this project over. He has contacted Public Works Department to see if it will work with their schedules and budget.*

*Selectman Santolucito has been working with a resident who had ice damage from this past winter. He has been working with the Public Works Director who is going to resolve the issues. He also attended the Town Meeting on Saturday, adding there was a rather low turnout from years past.*

*Selectman Santolucito congratulated Chief Schools for completing his master's degree in Public Administration, he has accomplished a lot in the past few years, moving the Town into an ISO five rating. He's a great asset to the Fire Department and our town.*

*Selectman Harmon also attended the town meeting, adding that all the articles passed with the exception for two roads that have not had the final coat of pavement yet. They will be paved within the next week or two, they will then be brought forward at a special town meeting.*

*Selectman Harmon spoke with Assessor, Bob Gingras of Parker Appraisal, the Board is requesting an analysis of where we are value wise. Compared to recent home sales our*

*Public Comments and Questions*

*Trudy Kent asked why the Board chose tonight to determine the Chair and Vice Chair positions without a full Board. Selectman Harmon explained that the Town Charter and Rules of the Board states "at the first meeting following an election in which a Selectman is elected, is to elect a Chairman and Vice Chairman for the ensuing year". She thought the vote should be postponed.*

*Ellen DeCotiis said it's been months since the events in three newspapers occurred, why the Board hasn't discussed the case with the residents of this town. Selectman Harmon said this is between the State and the parties involved and no tax payer money is being spent. Selectman Santolucito said it's a contentious situation and people are concerned. It has been made clear to Board members by law enforcement, not to discuss the issue with the case. It's clearly between the State and parties involved, let the Courts decide. Ms. DeCotiis is instructed to contact Town Clerk, John Myers for the Recall process.*

*Miriam Rubin continued to discuss the case by reading a letter she wrote. Ms. Rubin was reminded the Board was instructed not to discuss the case. Ms. Rubin continued to read the letter, she wanted it recorded in the minutes (Ms. Rubin's letter is attached for the record). Selectman Santolucito stated that so much of what was just read does not represent the person he has sat next to for five years.*
