Public Comments and Questions

Garry O'Connell, a resident from Towle Street asked questions concerning a town owned property located on Map 12, lot 4. Mr. O'Connell is requesting for the town to put the

property up for a sale or bid to bring it back to a residential lot. He would like the opportunity to purchase the property. Selectman Blier said the Comprehensive Plan Committee had been looking into potentially combining the property with another parcel and using it for future community uses. He also stated his position, which is to not put it out to bid, but to hold it for future community land. He then explained the process if the Board was to put out to bid.

*Ellen DeCotiis asked if the Board could listed the fire truck meetings posted on the sign out front and what the grants were used for within the fire department.* 

Chief Schools said the Reginal Grant, shared by the towns of Windham, Standish, Gorham and Buxton was used to upgrade our radio systems, which include portable radios on the firefighters, radios in the vehicles, pagers and vehicle repeaters. The total grant was \$499,000 split between the four towns. With this grant the federal government grant pays ninety percent and town pays ten percent, making Buxton's portion approximately \$10,000. These were all worked in during the budgeting process.

The second grant was the Large Diamond Hose grant, which is for the supply hose. This grant was hosted out of Gorham and included Gorham, Standish and Buxton. He believes it was over for a quarter million dollars divided between the three towns. It replaced all the large diamond hoses and all of the fittings needed for that hose on all of our fire trucks. Again, the federal government payed ninety percent and towns payed ten percent. Our Firefighters will have better communication during fire calls.

Selectman Poitras asked Town Clerk John Myers for a timeline to draw papers for the vacant Selectman's seat. John Myers said in order for the time to be shortened, he will draw up the proper for the Selectmen to sign nest Wednesday night, October 30<sup>th</sup>. Registered voters will be able to take papers out on Thursday, October 31<sup>st</sup>. Miriam Rubin clarifies the timeline with John Myers There was further conversation on the workshop for the fire truck.

*Cheryl Huntley asked why we can't take the Selectperson who lost from the last election. Due to State law and the Town Charter does not allow this.* 

*Miriam Rubin asked the Board to consider establishing a Conservation Committee for residents to stay involved in the town.* 

Trudy Kent asked for the workshop for the fire truck to post on the web site and asked about bringing Hazardous Waste Day back to Buxton. The Select Board will look into the Hazardous Waste Day.
