Selectman Peters attended Public Works interviews on Tuesday night. Kevin Kimball also updated him on the Crews progress with the shoulder work and to wrap up the remaining earth work for the close of the season. The salt shed is almost finished and the sand is scheduled to be delivered on November 11th

Selectman Peters reminded everyone that tomorrow is Halloween and to use extra caution

Selectman Santolucito has been working on the assessing, stating that every tax payer will received a little over one hundred dollars in January/February as part of the tax relief process. He thanked Tax Collector LeeAnn Pratt for all her assistance with this project.

He also worked on the Municipal Evaluation Return yesterday at the town office. This is an annual inventory report of the town of Buxton's exemptions, which include tree growth, farm land, open space, homestead, veterans, and power lines and transmissions. He is still reviewing the IT bids and will award the contract next week.

Selectman Blier spoke with the General Contractor of the salt shed, he chose the colors for the trim to match the Transfer Station as best as possible.

He spoke with a lighting contractor regarding the exterior lights, the Contractor said the town could recoup its money within a year, if we upgraded to LED's.

He has also been working on getting quotes to re-shingle the leaky shed roof, that is needed before winter and he was in attendance for the Public Works interviews.

Selectman Blier informed the public of an MDOT meeting at the Salmon Falls Bridge on Thursday, October 31st at 1:00PM. He feels there is a need for a safer pedestrian crossing.
