## *Review of Projects and Issues*

The CDC is still stressing social distancing and proper hand washing will help protect us. The Boards concerns are with the health and welfare of the residents, and employees. He also attended the budget committee meeting on Tuesday night, where the Fire Departments budget was reviewed.

Selectman Pulsoni has been keeping up with the coronavirus updates and reviewing the correspondence.

Selectman Blier had discussions with Code Officer Peter Gordon on how that department will run on limited hours of operation. He also spoke with Kevin Kimball regarding having equipment ready for the next storm and with the town's accountant regarding a five-year projection on the replacement of capital items.

*Selectman Blier was also in attended at the Budget Committee meeting. Everyone is doing well, the town is moving forward, the bills are being paid. It's a good thing.* 

Selectman Santolucito was not able to attend the budget committee, but he did have a brief conversation with Chief Schools on some of the policy issues regarding leave during COVID 19 and staying on top of everything with all department heads.

Selectman Peters attended the two COVID-19 conference calls and chatted with Public Works Director Kevin Kimball regarding the storm and dealing with his staff. He also had a discussion with Attorney Campbell Badger regarding police union negotiations.
