She will be using the fire chief's old vehicle to transport water and equipment to the programs. The vehicle has been stripped of all fire related paraphernalia and checked out by the town's mechanic, it's registered, inspected and ready to go.

5:00PM – Valeri Messana, Berry Library Librarian informed the Board on how she is planning to slowly open. On June 1<sup>st</sup>, she is planning to start a curbside pick-up book program through the website. During the quarantine time she has been reorganizing the children's section, computerized card catalog and familiarizing herself with the library in general.

At 5:30PM the Board went into executive session for Union Negotiations per 1 M.R.S.A. § 405 (6) (D) and out at 6:00PM.

Treasurer Kim Beam was in at 6:00PM, looking for signatures on a quick claim deed, and guidance on how to pay an employee during the quarantine.

Selectman Blier spend several hours on the union negotiations, talking with attorneys getting comps on hours and wages from other towns. He met with Chief Schools, the Engineer and Contractor regarding the Bar Mills Fire station roof.

Met with Public Works Director, Kevin Kimball in regard to the roadside mowing and he was able to talk with Valarie Messana at the Berry Library where some work has been completed.

Selectman Blier also met with the contractor to enclose the glass on the front counter. It looks good.

Selectman Poitras made a few phone calls and received communication from the fire chief regarding the new fire truck, which he will discuss below under 'Public Comments and Questions'.

Selectman Santolucito stopped at the Transfer Station to see how the opening went. It was working well. He also met with Peter and Kert on reopening of the town hall.

He also had discussions with Maine Revenue Service, they had questions on the approach we used to get the values we showed on the Tree Growth and Homestead programs. Its resolved confirmed we a certified at one hundred percent. Selectman Santolucito
