Quarterly update with Recreation Director Nicole Welch

Nicole Welch thanked the Board for the opportunity to showcase what the Recreation Department offered to our Buxton residents during COVID-19. In March we had to come up with ways to engage the community, from the kids to seniors.

What is our mission

- 1. Community Connection
- 2. How to connect by Social distancing.
- 3. Encourage Healthy lifestyle choices.

All by following CDC guidelines

She started several outreach programs, a Postcard Champagne, where they sent over 700 postcards to kids and our Seniors. Everyone likes mail! Some had word a search with action words, like run, jump, or sing on them. We had a Family Trivia Night, which was a Social activity through zoom. A Galaxie Salsa Bingo Night and virtual fitness classes featuring local teachers. Rhonda Davis of Happy Hearts Movements and Sarah Crosby's yoga. They were happy friendly familiar faces to all the kids.

Other programs included a Fitness challenge through strava – this was another way for "like minded residents" could connect with each other. Other programs included The Eggscellent Easter Showcase, Musical Instrument Wednesday, as well as maintaining a daily Facebook presence with treasure hunts. One of our main drives was to encourage families to get outside and into the parks of Buxton. In July we made flyers showcasing information about the local parks and what they had to offer. A Storyboard Walk was created at Town Farm Park. It was 16 to 20 pages from a book of a Maine Author. We posted the laminated storybook pages along the trail system at Town Farm Park. It was well received by the community.

We did a State driven initiative called Maine Back Yard Campout Weekend. Fifty-six families participated. It was set up to encourage families to camp for free. They don't even have to leave your home and they can stay safe. We dropped of 56 backpacks full of family fun activities, such as fire safety tips from the Fire Department, scavenger hunts, smore' recipe book, and sun safety packet etc.

Our biggest program challenge was the 2020 Summer Camp Experience, where we support our Buxton families under the CDC Guidelines. They had so many challenges in this 8-week program that was held completely outdoors and no field trips. We had smaller numbers in our groups, no building to stay in and no running water on site. The Staff was very creative and adhered to the guidelines.

Nicole expressed how proud she was of her staff for all COVID-19 health and safety protocol the staff had to adhere to throughout the summer program. This included brining water in daily, sanitizing the sanitation stations, sanitizing port o potties and all the games and equipment before and after use. Our goal was to keep the children of our community safe and happy.

What's Next? The fall soccer program and All Day Child Care Programs at Buxton Center Elementary School. Due to the school schedule this year, our program will run Monday thru Thursday from 7:00AM to 5:50PM. We were asked to give homework support for the kids. This program is full at this time. We are also hoping to setup a fitness trail for families at Town Farm Park. The Board thanked Nicole for her excellent presentation and her creative support for our community.
