#### Public Comments and Questions

Scott Warchol, Budget Committee member asked questions regarding special town meeting held last Wednesday. He asked what are the capital items the Board wants to pay cash for this year. Selectman Blier explained that the Boards plan is to pay cash for our capital items rather than financing multiple payments over a number of years. The goal is not to make the taxes go up and down. There is money in designated funds to keep the mill rate flat and for the next several years, we can remain flat.

Going forward are you planning to take the money out of undesignated funds? This will be a further discussion for the Board and Budget Committee. Mr. Warchol would like to see a plan. It would be helpful for the residents and the Budget Committee members. The Board will be setting a special town meeting and they would like the assessor here to answer questions. Mr. Warchol feels this is not an emergency and thinks the Board should wait to have this at the June town meeting. Selectman Blier explains the urgency was due to the time frame of having to complete the revaluation by April 1st 2022.

New resident Jim Maxfield introduces himself and would like to be involved in the town's future.

Richard Fitzgerald informed the Board about what was happening at the capital in Washington D C. This is a National Disgrace.
