Scott Warchol worked on and presented a solar farm ordinance, and we also discussed amendments to the sign section, LED signs are currently not allowed with our current ordinance. They will have someone from a sign company to come in to review options.

He also spoke with Public Works Director Kevin Kimball regarding the road survey before he came in tonight.

Selectman Field also attended the Planning Board workshop, a lot of good information and hopes to have it for the town to vote on it in June.

On Sunday, he and the Park committee members met with a young man who is preparing for his eagle scout project. He will be doing some bridge projects at the Park and we look forward to working with him.

Selectman Poitras worked with EMA Director Chief Schools regarding COVID-19 exposure.

Selectman Blier was also in attendance at the Planning Board meeting Monday night. They discussed putting a committee together with two Selectmen, two Planning Board members and two residents. They would revamp the Building Design Standards portion of the Zoning Ordinance for June 2021 town vote rather than June 2022. The Select Board felt that June 2022 was a long way away and they would like to try for something this year.

He asked the Selectman to set up a program to contact the elderly residents in town for vaccine location information. Selectman Blier stated we do not have any control. The CDC had the plan.

The Centers for Disease Control have a four-phase plan for vaccines. Selectman Poitras as the local Health Officer stated that the Select Board has no control over who gets the vaccine. The CDC hopes to do a 1,000 vaccines per day. They plan to set up mass sites by county. Sanford will be set up for York County. He reiterated that there is no local control.
