The Selectmen recited the Pledge.

Selectman Poitras apologized for the recent audio issues with the meetings and assured the public it will be resolved soon.

Quarterly report with John Myers and Ruth Scheibenpflug

Ruth Scheibenpflug voter registration updated the Board with statistics of the following categories:

39 Registered voters have passed away between September 9th and today.

303 new voters

371 moved out of Buxton.

240 changes which would consist of address or name change.

Our current total voter count is 6,813.

Currently she is working on 177 petitions for the CMP Corridor and certifications of the petitions.

The School District Budget vote is May 27th at 6 pm

Town Clerk John Myers informed the Board of what's new and happening out front in the town hall. Nomination papers available for the June 8th town meeting. One seats for the Board of Selectman, Two positions open for the Planning Board and two seats for the Budget committee. Nominations papers are due back in the Clerks office by 4:30pm on Friday, April 9th

The June 8th absentee ballots are available on May 10th along with the MSAD#6 District Budget Validation Referendum Absentee Ballot school budget.

The Board of Selectmen, himself and Angel Michie interviewed 6 candidates for the Deputy Town Clerk position. We hope to have the position filled by mid April.

Selectman Peters commend Chief Schools and everyone involved on the vaccine clinic. He has heard nothing but good comments from several people. It's a great thing they're doing.

Selectman Field was in for the interviews and talking to Kevin Kimball regarding the quotes for the new plow truck. At Pleasant Point Park a tree fell on an abutter of the park. The Public Works crew came out and cleaned it up. The abutters were very pleased that it was taken care of so quickly.

Selectman Field mentioned that so many people have responded to how professionally run the vaccine clinic was and they really appreciated the town holding it.

Selectman Poitras in touch with Chief Schools regarding a couple of issues and he also had a conversation with Recreation Director Nicole Welch.

Selectman Blier spoke with Kandice Talbot regarding building permit fees, he wants to make sure Buxton is in line with other surrounding towns. He also asked Accounts Payable, Amanda Schmechel to check on the frequency of fuel deliveries and increase of usages since the heat pumps were installed. She is also comparing fuel prices from other fuel companies. The Towns current fuel contract has lapsed and he is comparing prices with surrounding companies.
