Quarterly Report from Code Enforcement Officer Peter Gordon

It's been a pretty busy Spring. so far this quarter the Code Office has issued 12 new house permits, 7 garages, 9 additions, 1 Demo and 29 miscellaneous permits.

Currently there is a solar farm proposal on the Planning Boards table. This permit alone could cover the department costs for the year. If the law from the legislature is passed, enforcing each town to allow unattached accessory dwelling units with reduced setbacks, could open up a lot of issues for many towns. He adds that the office has been very busy.

Peter informs the public that his hours will be changing as of July 1<sup>st</sup>. He will be working four ten-hour days, Monday thru Thursday. He may be available on Friday mornings if needed.

Selectman Poitras received a call from the food co-op regarding water pressure at the pantry. He met with Facilities Manager Kert Jackson at the pantry and they have resolved the issue. He also spoke with the representative for the Solar Farm project off Haines Meadow Road. They were looking for information regarding testing records, he referred them to the Code Office.

Selectman Field spoke with Public Works Director Kevin Kimball last week regarding the paving bids and with Transfer Station Manager Greg Heffernan about issues at the Transfer Station. Adding, it's been a pretty quiet week.

Selectman Blier informed the residents that at the town meeting they voted to approve to have the town reassessed this year. In about a month the assessors will be coming around to each home. This will include them getting out of their vehicles, knocking on doors and walking around your property to assess all buildings. The town will also be changing over to the Trio assessing program as well.

Selectman Pulsoni has had a pretty busy week talking with Chief Cline and Chief Schools regarding personnel issues. He also spoke with the front office staff regarding letters for two employees whose hours are changing effective July first.

Selectman Peters came in Friday morning for start of the Police Union Negotiations. We are starting this process early and will be meeting every couple of months.
