The system should be moved and complete by next week. He also attended the Maine Revenue Program and touched base with Bob Gingras of Parker Appraisal.

Selectman Harmon said she received three more signs for Pleasant Point Park, the Public Works Crew will have them installed by the end of the week. The signs show the park rules, times it opens and closes, etc. Making the public aware of the rules and to move their vehicles out of the parking lot by 8pm or they will either be locked in or towed.

Selectman Poitras spoke with Tom Kennie Public Works Director concerning a grading issue on Long Plains Road, the State had done shoulder work and needed some attention. He also followed up with the Police Department, clarifying an issue concerning a ticket issued to a resident for a license plate misunderstanding.

Selectman Blier was away last week, but he did speak with Kandice Talbot in the Code Office regarding the community space behind town hall. She is preparing a map for DEP that they will accept. He has also been dealing with venders on the A/C unit in the town hall.

Selectman Emery has been driving around town where the Public Works crew has been cleaning up after the last storm and doing some ditching on Groveville Road. The Board has working on an issues with the owners of Curtis Farms Road. The board will forward their recommendations to the town attorney.
