In Ellsworth, due to the lack of a market for certain recycling products, they do not accept box board, office paper or glass anymore. We will look at the cost of what we are taking in. The only other option is to put it back in to the curbside trash pickup and into a landfill. The Board will look into this further.

Our heating issues have been resolved at this point. On Monday we had a computer issue. They are now back up and on track, except for one that was the source of the infection. Hope to have it back soon.
