# **Public Comment and Questions**

**Lisa Crockett-** With the resignation of Chief Cline, how does the board plan to fill the position?

Selectmen Pulsoni-We will put the position out to the public and accept applications

**Lisa Crockett-** Has the new K-9 team been in training all year, and how much have the Buxton taxpayers had to pay for the dog and his handler? The k-9 is being teamed up with the Southern Maine Emergency Response Team, who pays for that, and how much does it cost the taxpayers.

**Selectmen Pulsoni** - A lot of the cost of the dog and handler is paid by the grant we received. I don't know if all of it has been, but we will find out. As to sending the dog to train and respond with other emergency response teams, we have a mutual aid agreement with other towns, agencies, and response teams. They help us, and we help them, whoever sends the team absorbs the cost.

**Lisa Crockett-** Is the Public Works Director a working director?

**Selectmen Pulsoni-** He was hired as a working director; he goes out with the men. However, he does have office responsibilities in the office and garage. He meets with vendors and contractors and runs errands. We have all seen him out there working with the guys.

**Lisa Crockett-** Is there a rule about family members working in the same department.

**Selectmen Peters-** We never implemented a nepotism rule because it is too hard to get around it in our community. We have firefighters and volunteer firefighters are related, and we have other employees in different departments who are related. Its just what we have to do to get good people and fill our positions.

**Lisa Crockett-** The new mechanic doesn't have experience working on big trucks, only equipment. I have heard he has made mistakes.

**Selectmen Blier-** We vetted him when we hired him. We talked with people, and the recommendations were that he was a good mechanic. The Public Works Director thinks he is doing a good job. He is new, so let's let him settle in.

**Dave Harmon-** When people bring questions or comments to this meeting, it should be discussed in the next meeting under old business.

**Selectmen Pulsoni-** I will call her personally, and we can discuss the issues in the next meeting.

**Dave Harmon-** Does the town make any money on selling town owned properties.

**Selectmen-** We try to recoop the money that we have spent on the property, so we put it out to bid at that amount.

**Selectmen Blier-** We don't collect taxes on the property while we own it, so over a few years that adds up.

**Dave Harmon-** I asked about the Property at Emery Ranch, and that the money was still in the account, but it would not be enough to tear down the 2 buildings. Can the money cover the cost to tear down one. Are we passed the period where heirs can come forward and claim the property.

**Selectmen Blier-** That bid is now 4 or 5 years old. So it's probably substantially higher to do the work now. We would have to start the process over. The heirs came forward a couple of years ago, and we haven't gone all the way through that process. It takes time, and we want to give them the greatest opportunity to reclaim their families land by paying the taxes.
