Public Comment and Questions

Dave Harmon- I had 3 or 4 people ask me about the Treasurer's position, where is the money for that wage coming from. It's higher than usual.

Selectman Blier-We put a higher amount because we want to try to get a CPA in here, and that would cost more. Our current Treasurer is dropping down to part-time, so that would free up some funds.

I would also like to address the Town as a state legislator- The legislative session has convened, but there may be another veto session. I would just like to address 2 laws that may effect our residents here in Buxton. First, The Property Tax stabilization law has been removed, but it will remain for this years filers. In the future, m2024 and on, single people making \$80k or less will get a \$2k deduction, and people filing jointly making under \$150K will get a \$2K deduction. If you are behind on your taxes up to 2 years, the state will pay the taxes, but will place a lien on the property.

Some other things that came out of the legislature this year, the Dot used to have to come ask the legislature for money to tar roads, but we allocated \$200 million that will be funded by a tax on the sale of cars and parts, instead of just from fuel taxes.

People that are on public pensions will no longer have to pay taxes up to \$43K instead on 35K. We also worked on a minimum wage increase, but it did not clear the appropriations committee, but will be taken up later. The legislature also passed paid FMLA leave, with 1% coming from the employers with 15 or more employees and 1% coming from the employees. That is up to 12 weeks FMLA for each employee.

The ADU bill requires communities to pass the new zoning rules by January 2024, or selectboard communities to pass by July 2024.

We did a lot of work, and there is still a lot of work to do, but I appreciate you allowing me to serve as your representative in Augusta.
