# Public Comment and Questions

**Dave Harmon-** Last week accounts payable was only like \$15K, why? Also a few week ago the comment was made that the way transfer station fees were recorded was different than it is now

*Selectman Field- Our accounts payable employee Krystal Dyer was out of Town, in addition the large increase this week was from the school budget.* 

Selectman Blier- The way they record it at the transfer station is the same, but they have separated the fees from the Treasurer's end. They have essentially separated the weight and disposal cost and fees. It was hard to tell what we were being charged by weight with the old system. This just helps us track cost fluctuations from year to year.

*Lisa Crockett- Something was brought up about using covid(ARPA funds) about using it on a new dispatch system.* 

Selectman Blier- We received about 820K in ARPA funds. The money came in 2 payments. We used 150K of it to replace emergency medical equipment for the first responders, and the rest of the first payment was used for employee bonuses. We want the remainder to help update the our failing emergency communications systems. We will put it out to the town in the annual meeting to see if they will vote to allow that expenditure.
