Called to Order at 7:00

The Selectmen recited the Pledge.

<u>Clay Gleason:</u> Superintendent of the Bonny Eagle School District- This year's budget is smaller than last year. Our baseline increase came in under 2%. We are expanding pre-K with another class in Buxton. We are looking for 2 new special education teachers to accommodate our growing special education population. Our facilities are getting older, and we have 30 million in deferred repair costs. In this budget we approved a 1.5 million request for facilities repairs that are urgent. The total increase will be 5.6% overall over last year, and 3.3% increase for Buxton or about \$302,000.

<u>Selectman Blier-</u>Congratulations on being hired as the new superintendent. We want to know what your vision for the future is, especially with growth and facilities. Did the engineering firm you hired come back with the final amount? With a shrinking student population, can't we get rid of some of the temporary buildings and things.

<u>Clay Gleason-</u>Last year there was a condition assessment of all the sites. We are looking at our options. We hired an outside company to help us, and we are doing surveys. We are developing a plan based on those findings. The planning group meets monthly, and our goal is to have a proposal by next year. We are relying on experts to advise us about population growth so we can be as close as possible. The engineering firm returned a number at about 30 million for deferred maintenance, but that does not include updates for learning environments and new technology. So, we are still trying to assess those costs.

As far as the temporary buildings and spaces we repurpose those for things like our growing pre-K population, special education, and other uses like speech therapy sessions.

Public Comment and Questions

<u>Paul Leach-</u> I was part of the BAC for MSAD 6. Do you review the budget that they are approving. Also do you look at the last budget and verify the spending. I Noticed that they spent about 2.3 million less than they ask for. It doesn't seem right that they don't spend money that we allotted to them, and then they ask us for more and increase our tax burden. I spoke to them about it, and they were very dismissive.

<u>Selectman Blier-</u> We receive a packet of information from them, and we review that packet. We do not go back and look at past budgets to see what the performance was. The BAC recommends a budget, and it is voted on in our town meeting. It is also voted on in a public meeting of the school district.

Last year we did not approve of the budget, we spoke against it. I think the balance has shifted too far in the direction of the schools. We have no other influence than what we

have done. We were out voted in the general school district meeting, so we have about as much pull as regular citizens. The residents need to show up and voice their opinion at the Town Meeting in June, as well as the annual MSAD meeting where the budget is voted on.

<u>Steve Plimpton</u>- I am a career firefighter in a neighboring community, and I was a past employee at the Buxton dispatch. I live here in Buxton. I believe the emergency communications system here in Buxton is severely outdated. In the recent fires this week we had a delay in communications of about a minute and a half. That is a lot in emergency terms. The system here in Buxton needs to be improved.

<u>Selectman Pulsoni-</u> I agree that the system is outdated, and we are working to rectify that. The timing frame that was put in the press release was a little off from what the actual time was. I know some people have recommended letting the dispatch go to Scarborough, but I think that is a bad idea. We would then have little control over how calls are handled, and we would be paying them for a service. In addition, many of our programs like elder care checks would have to go away, because Scarborough or another town would not do that for us.
