The Board met Kathryn Sovetsky, the new Librarian for Berry Memorial Library. Kathryn will meet with Claudine Emerson Monday and the library will open Tuesday.

Chief Schools met with the Board. They talked about the Fire Department banquet next Tuesday evening, a letter of recommendation the Chief is looking for, and the new fire truck.

Maine Power Options estimated they could save the town around \$10,000/year. The contract went into effect in December and between then and June, we saved around \$5,000.00.

Selectman Emery has been working with people from Great Falls Construction who put together the RFP for the addition. He is helping get information together for the packets that will be sent to the list of contractors who will be invited to send proposals. He stated that he has the wording for the posting that will go into the Portland newspaper in the next few days.

Selectman Harmon has been reviewing resumes for the Selectmen's Assistant job. She and Selectman Blier are going to meet with the Union Representative tomorrow.

Our extended Recreation Summer Camp is taking place here in the large meeting room for a couple weeks. It has been going very well and Selectman Harmon said the children seem to be having a great time.

Selectman Blier participated in interviews Monday night for the Public Works position. He said he thinks the young man they hired will be a good fit with the crew. Selectman Blier spent time contacting some of the Comprehensive Plan members about their upcoming meeting. He also spent time going over plans for the addition.

Selectman Poitras attended the Pirate's Fest in Hollis last weekend and mentioned some conversation he had there.

Selectman Santolucito has been working on resolving a technology issue for the link between our systems in the front office and Trio Software. He participated in the interviews for Public Works and has been working on the electric rate review. The Board will make some decisions on that after Labor Day. Selectman Santolucito went to the fire station last week and met several of the firefighters who were putting equipment on the new fire truck that will go into service in October.

Rich Streeter went to the podium to comment on the article for the marijuana ban and to ask the Selectmen to consider splitting that into two parts; one banning recreational sales and social clubs, and another one for banning testing and growing facilities. Mr. Streeter addressed some previous objections, talked about his conversation with Don Marean after his trip to Colorado, and shared his (Mr. Streeter's) thoughts on what facilities he thinks will be the best to keep and what may generate the most revenue and tax benefit for the town. He believes the town has an opportunity to bring in more revenue.
