Other Business

Public Comments and Questions

Dave Harmon- Will the new trash bins be one size or 2, and how will they be handed out.

Selectmen- Casella will hand the bins out based on our town records. We don't know whether there will be 1 or 2 sizes, but it will probably just one size. We have to look at prices and other factors.

Dave Harmon- What happened to the house that was to be demolished on

Selectmen- We did raise about 50K to demolish that house, but when we were in the process some legal issues with heirs came out. We would like to see it cleaned up, but we have to deal with any potential legal issues. The money is still in the account, we just must reexamine where we are on it.

Selectmen- In regards to the trash bins, there are a lot of implications that we really need to discuss with the public in a meeting. There are potential issues with the lifespan of the bins, replacement scenarios and costs, and how we would repair damaged bins. These are still issues we need to explore.

Dave Harmon- Are they going to be able to finish the routes in 3 days with the new bins.

Selectmen- They are going to move to 4 days, they will use one truck. However, a smaller truck will be used on routes where the big truck will have trouble. We are still waiting on a lot of numbers from Casella about the new program. We need to have a public hearing once we have all the information.

Dave Harmon- They really need to be careful about powerlines and other obstructions with these trucks. I have seen a lot of damage in my job where trucks have snagged lines.

Selectmen- That is one of the issues we will have to make people aware of.

Patrick Hanna-Will there be serial numbers on the barrels.

Selectmen- If we let Casella manage the barrels, they will put serial numbers on the barrels, but that is more expensive. If we do it on our own, then we will have to handle

maintenance and mark the barrels ourselves, but that would be more difficult for us to manage.
