The Board will meet with the Police Dept. at 5:30, tomorrow night to review their budget. She was here for the Public Works Directors presentation at the budget committee meeting on Tuesday night and we're still waiting for the two new trucks.

Next Wednesday at 5pm the Board will review their budget items and the Planning Board is requesting for the Select Board to attend the Planning Board meeting on Monday, March 11 at 7:00pm to consider updating the marijuana ordinance to reflect current changes.
