Review of Projects and Issues

Selectman Santolucito reached out to Maine Revenue regarding the annual audit

Selectman Blier attended a Comprehensive Planning site walk at the open space behind town hall. They are coming up with a plan. He also spoke with Public Works Director Kevin Kimball regarding possibly having the crew cut and clear the trees in the area. It would be a big savings to the town. He also spoke to him regarding the collapsing of the salt shed.

Selectman Blier has been working with Krystal Dyer regarding the cost of the legal ad for 134 Cemetery Road bid package.

Selectman Blier announced that on Tuesday, May 28 at 6pm at the Hollis Community Building, the Maine Department of Transportation will be presenting a plan to resurface the Salmon Falls Bridge on Route 202. There will be discussion to potentially have a side walk added to the bridge during the resurfacing project. The meeting is open to the public.

Selectman Poitras received a call from a resident regarding a tree in one of our Ancient Cemeteries. Public Works will be taking care of it. He also spoke to Bob Lowell of the American Journal regarding the salt shed, which he referred him to the Public Works Director, Kevin Kimball.

Selectman Harmon announced that the sand and salt building at the Transfer Station, where we store our winter sand and salt, roof collapsed Monday evening. We had been receiving deliveries of sand throughout the day. It has been taken down due to safety concerns. Not sure of the cause at this time. It will be rebuilt. No one was hurt or no equipment damage.

Selectman Harmon attended the Planning Board Public Hearing on the Ordinance amendments. Yesterday she had the opportunity to walk through Pleasant Point Park to look at the picnic tables, bridges and wet areas. There are trees that will need to be removed and some erosion that is beyond our control. We will be coming into our busy season.
