Review of Projects and Issues

Selectman Blier reached out to Jennifer McGill of DEP regarding the open space project behind town hall. He is looking for approval in order to move forward on the project.

Selectman Blier also attended a preliminary DOT meeting at the Hollis Town Office regarding the reconstruction of the Salmon Falls Bridge. The current plan is to close the Salmon Falls Bridge during construction and re-route all traffic to Main Street (Route 4A). The Poland Spring truck traffic would turn left at Low's Store, directing them back to Route 112. He has a concern with routing traffic through the dangerous intersection by Low's. A traffic light during construction and a new sidewalk on the Salmon Falls Bridge was discussed. It was a good meeting. There will be more meetings, but none scheduled at this time. Construction is scheduled to begin in 2021.

Selectman Poitras had a couple residents stopped by his office and he directed them to the town hall to get further assistance. He also spoke with the Recreation Director Nicole Welch regarding creating a Town Hall page on social media. He added it would help get the word and updates out to the public.

Selectman Santolucito received an email from Maine Revenue Service, they are coming to perform their annual review of our property tax records on June 27th at 2:00PM

Selectman Harmon, as a member of the Pleasant Point Park had hired a local company Stonecraft to make two concrete picnic tables for the Park. They are beautiful! The Public Works Crew will be bringing them to the park this week. After speaking with a Pit Stop Fuel technician, Public Works Director, Kevin Kimball said the Propane tanks at the Public Works department need to be on a concrete pad.

Public Works interviews were held on Tuesday night, an offer has been made and accepted. We are waiting for paperwork and background check to be conducted.

Selectman Harmon announced that neither Skip Road nor Back Nippin Roads trash had not been picked up on Wednesday, she contacted Casella, but they had no information to offer as to why.

Selectman Emery attended the interviews last night. He has been updated on the progress of the sand and salt shed debris removal. The debris will be removed Thursday, May 30th, the sand will be removed and stored at a pit in Standish until the new structure is rebuilt.
