Review of Projects and Issues

Selectman Pulsoni has been in the office reviewing the town charter and attended the Budget Committee meeting. He apologized to the viewers at home for the meeting not being televised, there was a miscommunication. Selectman Pulsoni listed the budgets that were reviewed at that meeting. He added that he was in the office today familiarizing himself with all the town ordinances.

Selectman Blier attended the Fire Departments union negotiations last Friday. He announced they have hired a librarian at Berry Memorial Library and are looking for volunteers and trustees. They are hoping to reopen this Saturday, January 25th.

He spoke with Public Works Director Kevin Kimball regarding his budget and asked Treasurer Kim Beam about the town's debt. He was looking at the potential of refinancing some of town's loans at a lower interest rate. The only problem is, some of the loans were purchased with a bond, which cannot be payed off early.

Selectman Blier has also been looking into the Efficiency Maine rebates on heat pumps. They have raised the rebate amount. The Board discussed the potential of installing heat pumps at the two libraries. This would give air conditioning during the summer months.

Selectman Poitras had budget discussions with Treasurer Kim beam and also spoke with John Myers, MMA attorneys and resident Paul Baresel regarding the charter commission.

Selectman Santolucito had some general communion with Paul Baresel and Carol Sanborn regarding the charter. He has been working with Kim Beam with the ongoing IT upgrades that are being done remotely. He is hoping the upgrades will be done by the first of March. He spoke with MMA regarding upgrades for the insurance underwriters on the new IT upgrades. He also had the opportunity to ride in the plow truck with Director Kevin Kimball during the last storm. It's quit an experience and it gives you an appreciation of the work they do. The Crew does a great job. He reminds the community, that when you get up in the morning, those roads are plowed because the drivers have been out for many hours before you head off to work.

Selectman Peters also spoke with Kevin Kimball about a couple GMC trucks that are getting older and the parts for these trucks are getting harder to find. He commends the Public Works Crew for the hours and hard work they do.
