Transfer Station Director Greg Heffernan was in to review his proposed budget and as usual it was lean and will be forwarded for Budget Committee approval.

The Charter Committee did not meet as planned, but hope to next week so to review the marked up copy of the Charter. They do need to move on this soon, due to public hearing timeline requirements with the Charter amendments.

Representative Don Marean stopped by, he attended the State of State Address last night in Augusta. He updated the Board on Frye Island.

#### Review of Projects and Issues

Selectman Emery has been going over budgets and attended the budget committee meeting Tuesday night.

Selectman Harmon has been working on her budget components and attended the Budget Committee meeting. She has worked with the Towns attorney on a resolution to a code issue consent agreement.

John Myers suggested building a cover over the public access sand area. Public Works Director Tom Kennie is in favor of moving it, because it causes conflicts when the road crew is trying to load during storms and resident's vehicles are blocking the loading area. Selectman Poitras said it would be a great Eagle Scout Project, the Board agrees.

The Selectmen appreciate John Myers delivering buckets of sand to the elderly on his own time.

Selectman Blier agreed it was a great idea for an Eagle Scout project and suggested moving it to the front of the parking lot. He also attended the Budget Committee and the 12 Town Group meetings. He is currently working with a resident on a land swap in the Bar Mills area through the Comprehensive Planning Committee.

Selectman Blier added that the tile floor was laid down in the Police Department addition and he also worked on the budgets last week.

Selectman Poitras has been focused on pedestrian safety and traffic issues in the West Buxton Village area. He has been working with Public Works Director Tom Kennie on purchasing and installing dangerous intersection or pedestrian crossing signs on Parker Farm and River Road (Route 112) intersection.
