*Selectman Blier also worked with Kandice Talbot on finding aerial maps of the town hall complex to send to DEP for the community project behind town hall.*

*He worked with Jeremy Montgomery, Trustee of Bonny Eagle Park. They poured a couple cement pads in preparation to bolt the new garbage cans to the pad. Over the winter the ice moved the concrete barriers by the boat ramp. Tom Kennie saw cut the end of the boat ramp to repair it and bolt together the block to keep them from moving in the future.*

*Selectman Poitras spoke with Public Works Director, Tom Kennie about issues and projects he and his crew have been doing. They are currently cleaning up winter sand, ditching and replacing a culvert on Christian Row. They are doing an awesome job. The Board also received a thank you note from a resident for a job well done by the Public works Department.*

*Selectman Poitras also received a call from a resident concerned with signs being placed on town property with memorial monuments. They continue to search for an ordinance regarding signs on private vs public property*

*Selectman Santolucito received a call last Thursday concerning the installation of the surveillance cameras in the town hall and new addition. We are maximizing coverage by spending as little dollars as possible. Now there is excellent coverage of the building inside and out.*
