State Representative Don Marean updated the public on the Medical and Adult Marijuana matter. There have been several bills passed since his last visit. In June 2018 the town of Buxton passed an ordinance banning Adult and Recreational Marijuana. He reports that there has been one huge change with personal position of marijuana, it has decreased from six plants down to three flowering plants per person for anyone 21 years of age or older. Each person has six months to come into compliance, following the state of Colorado's bill. Each municipality may regulate registered primary care givers, registered dispensaries,

marijuana testing facilities and manufacturing facilities, but may not prohibit or limit the number of registered primary care givers allowed in their towns. There was further questions and discussion regarding LD1539.
