Review of Projects and Issues

Selectman Blier had spoken with Public Works Director Kevin Kimball regarding the open space behind the garage and upgrading the fuel pump operations system.

Selectman Poitras spoke with Kevin Kimball, Public Works Director, has some efficiency ideas for next year's budget.

Selectman Harmon had a visit from Kevin Kimball regarding budgets and paving roads. He brought in a copy of an engineer's report reviewing the roads in the town of Windham. The report gives an overview rating of the all the roads and their condition and then categorizes them in order of repair importance. The Director is thinking outside the box of how we have done things in the past.

Dispatch received a complaint of the flags in the town parks not being lowered to half-staff recently. Selectman Harmon adds that in the past 16 years she does not recall having anyone lower those flags. John Myers printed off a copy of flag etiquette, which we passed on to the Police/Dispatch Department. This particular flag was located at Weymouth Park, which is operated by Weymouth Park trustees and not by the town.

Selectman Santolucito had a brief discussion with Chief Cline, Officer Camire, Conrad Jellison and Advance Technology regarding upgrades to our server.

Selectman Emery also checked in with Public Works Director Kevin Kimball discussing numerous things throughout the week. He also spoke with Chief Schools concerning the upcoming budgets and Chief Cline about every day stuff.

Selectman Emery added he tried to contact Transfer Station Director, Greg Heffernan in regards to the Curbside pickup contract, which will be going out to bid this year.

Selectman Harmon said she spoke with Greg last week, he's following up on appropriated money for a 40-yard container that was ordered back in July.
