







Case Study

Officer is dispatched to the scene of a motor vehicle accident at 4PM on a Sunday afternoon. Upon arrival he notices an odor of intoxicants on the breath of one of the drivers and witnesses report believing he is intoxicated. A second officer is dispatched to provide both scene security and to assist with the accident and potential arrest.

- 04:05 Officer A conducts field sobriety tests while Officer B speaks to witnesses and begins an accident investigation.
- 04:33 Officer A notifies dispatch he has arrested the driver for OUI and will be transporting the arrestee to the police department for processing. Officer B will be conducting a vehicle inventory while waiting for a tow truck to arrive and collecting witness statements while gathering information needed for the accident report.
- 04:38 Officer A arrives at station and begins processing the arrestee to include fingerprinting, photos, reading Miranda, gathering information for the arrest report and conducting a breath test.
- 05:06 Officer B clears the scene. He will later spend 30 minutes completing an accident report and writing a supplement to Officer A's arrest report.
- 05:32 Officer A reports a breath test will not be possible and request a blood tech. Blood tech is contacted with an ETA of 25 minutes.

- 06:17 Blood tech arrives and completes a blood draw which is placed in evidence. This will now need to be delivered to the testing lab in Augusta for analysis.
- 07:01 a bail commissioner is contacted to set bail. Arrestee is allowed to make calls to family to bring him bail money.
- 08:07 Arrestee is bailed and released.
- The officer will spend approximately 2 hours reviewing video, notes, witness statements and other pieces of evidence in order to write a complete report that will be used for prosecution.
- At a later date the officers can expect to spend 2 hours in a BMV hearing and potentially up to 8 hours in court for motions, hearings and trials.

At the conclusion of this case, Officer A will have up to 16 hours invested and Officer B will have up to 11.5 hours for a total of up to 27.5 man-hours. This does not include support staff time.

Highlights

- During the first half of 2020, BPD removed 17 guns and \$15,000 worth of drugs from the community in multiple drug cases
- Two critical calls that could have had deadly consequences were resolved without injury including a police standoff and attempted arson
- We have welcomed 6 new employees to the team but are still searching for 2 more officers to fill the ranks
- The department worked with Carfax for Police to make accident reports conveniently available online
- The first edition of our newsletter "The Community Beat" was published and will continue monthly
- We are seeing issues at Pleasant Point Park and remind visitor there are no alcohol or drugs permitted in the park. Park hours are 7am-8pm and vehicles in the lot at closing will be towed. Officers will continue to patrol the park through out the day.
- While registrations of vehicles were delayed due to COVID-19, anyone who can register their vehicle at this point MUST register their vehicle.
